TERMS & CONDITIONS

GENERAL

- 1. The "Organizers" of "Sai Kung Art And About" (the Event) include Sai Kung District Council, Sai Kung District Office and Sai Kung District Community Centre.
- 2. All registered artists/participants of the Event will be referred to as "Artists" in the following Terms & Conditions. Each Artist agrees to respect and make sure that all staff under the Artist will respect the Terms and Conditions of the Event.
- 3. The Organizers reserve all rights and will make final decision in all aspects of the Event, including modifying these Terms and Conditions in the general interest of the Event without prior notice.
- 4. The Organizers reserve the right to make a decision at any time or in any cases that are not covered by these terms. These decisions, even if verbally transmitted, are to be executed within the time frame specified by the Organizers and without prior notice.
- 5. Apart from those who opt for participating art exhibition only, the Organizers require Artists to conduct the following THREE activities in their assigned space/ booths:
 - (1) Showcase the Artist' artworks as specified in the registration form;
 - (2) Do demonstration; &
 - (3) Provide participation opportunities for interested members of the public.
 - The above THREE elements have to be provided in each assigned space/booth.
- 6. During the Event, Artists are welcome to display artwork(s)(max. 150cm x 150cm) (max. of 2 pcs.) (please consider the weight) in the Sai Kung Jockey Club Town Hall (8th-12th December 2017), or at any specified outdoor spaces (9th & 10th December 2017).
- 7. The Organizers will set up avenue where selected artists will be invited to conduct an Art Demo **or** hold a Workshop. Allowance for materials for each Demo/Workshop is HK\$500.
- 8. This is a **Non-Commercial public event**. No selling of work or transactions of any kind is allowed. Publicity pamphlets however are permissible. Also, only the Name of Artist or Name of Non-profitmaking/Non-commercial Organization will be accepted as the name of the assigned booth.
- 9. All artworks must be family-friendly (only **Non-political and Non-sexual** art works are allowed).
- 10. Only selected artists or non-profitmaking/Non-commcercial organization are allowed to participate in the Event. Due to the limitation of space and to allow participation by more artists of diversified form of art, all registration will be screened and selected by the Organizers.


EXHIBITION

- 1. A 3m x 3m space/booth, 2 tables and 2 chairs with signage as well as overnight storage service can be provided for Artists upon request.
- 2. All Artists must be responsible for the running of their own assigned space/booths, including decoration, exhibition, cleaning and dismantling of their own works during the opening hours of the event.
- 3. For the sake of safety, all temporary structures must NOT be higher than 2M and should NOT occupy areas outside the booth unless with the prior permission of the Organizers.
- 4. No electricity will be supplied for each booth.
- 5. It is prohibited to let, sublet, share a part or totality of the assigned space/booth to another person without prior notice, should it be free or not.
- 6. The Organizers reserve the right to remove any unapproved items during the Event.
- 7. Should the artists decided to withdraw from the event, a written withdrawal notice should be submitted on or before 24thNovember, 2017 to the Organizers, so that the assigned space/booth can be re-allocated to other interested artists.
- 8. All Artists will have to provide and get materials for their booths by themselves. The Organizers will provide \$250 as materials cost for each booth per day.

ARTWORKS

- 1. The Artists are responsible to ensure that all artworks/artwork images are authorized for the use of the Event in accordance with Hong Kong Copyright Ordinance(Cap 528).
- 2. Different types of artwork are welcome, including:
 - i. Fine art : Paintings, Sculpture, Collage and etc.;
 - ii. Street art: Graffiti, Pastel graffiti, Spray paint and etc.;
 - iii. Craftwork: Embroidery, Wood carving, Pottery and etc.;
 - iv. Artistic Photography;
 - v. Folk art; &
 - vi. Any other creation activities.
- 3. All artworks displayed during the Event and artwork images submitted by the Artists to the Organizers may be used as part of the Event's publicity before and after. The Artists will be credited where possible.

Artists and their respective insurers must renounce the ability to claim any of these elements against the Organizers.

The Exhibitor shall comply with all applicable laws, regulations and codes of practice in relation to participating in the Event, including without limitation, all local laws and fire and safety regulations, the rules and regulations set out in these Terms and Conditions and any additional rules imposed by the Organizers or owner of the Venue or the Government.
