Practitioner's Responsibilities (continued)

The work undertaken in connection with this engagement is less in scope than an audit conducted in accordance with Hong Kong Standards on Auditing and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.

Our engagement included carrying out limited procedures for obtaining sufficient appropriate evidence to be able to draw a conclusion, such as inquiries primarily of persons responsible for financial and accounting matters and other procedures we considered necessary. The procedures performed in a limited assurance engagement vary in nature and timing from, and are less in extent than for, a reasonable assurance engagement. Consequently, the level of assurance obtained in a limited assurance engagement is substantially lower than the assurance that would have been obtained had a reasonable assurance engagement been performed.

Inherent Limitations

Due to the nature of cash receipts and expenses relating to the Event, it was not practicable for us to determine whether the income and expenditure account and the books and records of the Permittee include all transactions relating to the Event. It was impracticable for us to quantify the potential impact of this on the income and expenditure account. Accordingly, our report relates solely to the income and expenditure account prepared from transactions that have been recorded in the Permittee's books and records.

Conclusion

Based on the foregoing, we report that nothing has come to our attention that causes us to believe that the attached income and expenditure account does not reflect, in all material respects, the gross subscriptions raised and the expenses incurred by the Permittee in respect of the Event that have been recorded in its books and records made available to us in accordance with the basis of preparation set out in note 2.

NOTES TO THE INCOME AND EXPENDITURE ACCOUNT FLAG DAY – NEW TERITORRIES REGION FLAG DAY ON 18 JULY 2020 PUBLIC SUBSCRIPTION PERMIT NO.: FD/R064/2020

1. General information

The New Territories regional flag day fund-raising activity held on 18 July 2020 ("the Event") was held to raise funds for:

- (1) parenting support and education services to deprived families with toddlers in Sai Kung rural area;
- (2) health care and supportive services for elderly in village area and to expand service site in villages; and
- (3) to explore service model for primary health care in rural area and promote medical-social collaboration.

However, due to the COVID-19 epidemic, the street selling of flags scheduled on 18 July 2020 was cancelled. Online flag selling was used to substitute street selling of flag.

2. Basis of preparation

The relevant income collected and expenditure incurred for the Event are recognised on an accrual basis.

3. Donations credited to the bank

The Event proceeds collected amounting HK\$142,263 and HK\$10,000 have been credited to the designated bank account of the Permittee by 16 September 2020 and by 22 October 2020 respectively, before being used for payment of expenditures for the Event and/or the purposes specified in the Public Subscription Permit.
